

ORDINANCE NO. 148

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS BARTLETT HEIGHTS ADDITION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to wit:

A subdivision of that portion of the NW/4, SE/4 of Section 3, Township 15 North, Range 25 East, Adair County, Oklahoma, described as follows: Beginning at the northwest corner of said NW/4, SW/4; thence North 89 degrees 39' 26" East, 300.00 feet; thence South 0 degrees 06' 22" East, 748.00 feet to the true point of beginning; thence South 0 degrees 06' 22' East, 252.00 feet; thence North 89 degrees 39' 26" East, 530.00 feet; thence North 0 degrees 06' 22" West, 392.00 feet; thence North 89 degrees 39' 26" East 140.00 feet; thence South 0 degrees 06' 22" East 532.00 feet; thence South 89 degrees 39' 26" West, 810.00 feet; thence North 0 degrees 06' 22" West, 392.00 feet; thence North 89 degrees 39' 26" East, 140.00 feet to the true point of beginning,

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the **BARTLETT HEIGHTS ADDITION** to the City of Stilwell, Oklahoma, and the boundaries of said City are herewith changed to correspond to the legal description first above given.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists; therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
