

ORDINANCE NO. 205

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS THE JOHNSON ADDITION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to wit:

A part of the SE/4, NW/4, SW/4 of Section 2, Township 15 North, Range 25 East, Adair County, Oklahoma, being more particularly described as follows: Commencing at the Southeast corner of said SE/4, NW/4, SW/4,; thence North 103.14 feet to the Northerly right-of-way line of State Highway #100 for the point of beginning; thence along said right-of-way on a curve to the right having a radius of 1623.28 feet and a distance of 449.43 feet; then continuing along said right-of-way North 53 degrees 17' 32" West, 132.82 feet to a point where the Easterly right-of-way line of the Kansas City Southern Railroad intersects the Northerly right-of-way line of State Highway #100; thence continuing along said right-of-way line North 2 degrees 19' 56" West, 190.70 feet; thence South 54 degrees 05' 37" East, 244.33 feet; thence South 59 degrees 00' 34" East, 157.41 feet; thence south 64 degrees 42' 21" East, 98.00 feet; thence South 64 degrees 09' 52" East, 105.03 feet; thence South 156.23 feet to the point of beginning, containing 2.07 acres, more or less, less and except public road rights-of-way and being subject to any easement of record,

a plat of which said property is attached hereto and made a part hereof as thought described herein.

SECTION 2. That the real property herein described shall be designated as the **JOHNSON ADDITION** to the City of Stilwell, Oklahoma, and the boundaries of said City are hereby changed to correspond to the legal description first above given.

SECTION 3. That all ordinances or parts or ordinances in conflict herewith are hereby repealed.

SECTION. 4 WHEREAS, an immediate necessity exists; therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
