

ORDINANCE NO. 225

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND DESIGNATING SUCH TERRITORY AS THE BARKER-LAND ADDITION, DRY WELL ADDITION, MAPLE RIDGE ADDITION, MORTON ADDITION, AND OZARKS ELECTRIC ADDITION, ALL TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED by the Mayor and City Council of the City of Stilwell, Oklahoma:

SECTION 1. That the following described real property situated in Adair County, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to-wit:

BARKER-LAND ADDITION: A subdivision of the South 330.00 feet of the East 168.0 feet of the E-1/2 SE SW SE and of the South 289.0 feet of the West 573.30 feet of the East 903.30 feet of the SE SE of Section 27, Township 16 North, Range 25 East, Adair County, Oklahoma

DRY WELL ADDITION: A subdivision of the West 104.4 feet of the South 208/75 feet of the NW SW SW and the North 150 feet of the East 335.0 feet and the South 179.0 feet of the West 186.0 feet of the SW SW SW and the North 150.0 feet of the West 60.0 feet of the SE SW SW and the South 5.0 feet of the North 150.0 feet of the West 325.0 feet of the SW SW SW of Section 26, Township 16 North, range 25 East, Adair County, Oklahoma

MAPLE RIDGE ADDITION: A subdivision of the SE SW SE and the South 5.0 feet of the SW SW SE of Section 35, township 16 North, Range 25 East, Adair County, Oklahoma

MORTON ADDITION: A subdivision of the South 150.0 feet of the E-1/2 SW SE NW of Section 3, Township 15 North, Range 25 East, Adair County, Oklahoma

OZARKS ELECTRIC ADDITION: A subdivision of that portion of the NW NE of Section 27, Township 16 North, Range 25 East, Adair County, Oklahoma, described as follows: Beginning at the NE corner of the W-1/2 SW NW NE of said Section 27, thence S.0 degrees 01', 252.70 feet to the North line of State Highway No. 51 Right-of-Way; thence S.89 degrees 56' E, along said North line, 990.0 feet to the SW corner of the 1977 North Addition to the City of Stilwell, thence S.0 degrees 01' E, 45.0 feet; thence N.89 degrees 56'W, 152.87 feet; thence N.0 degrees 04'E., 302.70 feet, thence S.89 degrees 56' E., 152.43 feet to the true point of beginning

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as **BARKER-LAND ADDITION, DRY WELL ADDITION, MAPLE RIDGE ADDITION, MORTON ADDITION** and **OZARKS ELECTRIC ADDITION** to the City of Stilwell, Oklahoma, and the boundaries of said City are hereby changed to correspond to the legal description first above given.

SECTION 3. That all ordinances, or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists therefor, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
