

ORDINANCE NO. 261

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY AND DESIGNATING SUCH TERRITORY AS THE HIGHWAY RIGHT-OF-WAY ADDITION TO THE CITY OF STILWELL, OKLAHOMA; AND DECLARING AN EMERGENCY.

BE IT ORDAINED, by the Mayor and Council of the City of Stilwell, Oklahoma:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to-wit:

U.S. HIGHWAY #59 NORTH: All of U.S. Highway 59 right of way described as follows: Beginning at the intersection of the South line of SE SW SW of Section 26, Township 16 North, Range 25 East and U.S. Highway 59 right of way; thence Northwesterly to the intersection of the North line of the South 1100 feet of the E/2 SW SE of Section 22, Township 16 North, Range 25 East

U.S. HIGHWAY 359 SOUTH: All of U.S. Highway #59 right of way described as follows: Beginning at the intersection of the South line of the NW SE NW of Section 11, Township 15 North, Range 25 East and U.S. Highway 59 right of way; thence in Northerly direction along said right of way to the point of intersection of U.S. Highway #59 right of way and the 1922 Addition to the City of Stilwell (in SW NW SW of Section 2, Township 15 North, Range 25 East)

SH 51 EAST: All of SH #51 (formerly #100 East) highway right of way described as follows: The North 50 feet of all that part of the NE NW SW lying East of U.S. #59 right of way and the North 50 feet of the NE SW and of the N.2 SE of Section 35, Township 16 North, Range 25 East

SH 51 WEST: All of SH #51 right of way described as follows: Beginning at the intersection of the West line of U.S. Highway #59 and SH #51 right of way in the SE NE of section 27, Township 16 North, Range 25 East; thence Westerly to a point 152.87 feet West of the East line of W/2 SW NW NE of Section 27, Township 16 North, Range 25 East

HIGHWAY 100 WEST: All of SH #100 right of way described as follows: Beginning at the intersection of U.S. Highway 59 and SH #100 in the SW NW of Section 2, Township 16 North, Range 25 East; thence West to the intersection of the West line of the NE/4 of Section 4, Township 15 North, Range 25 East

HIGHWAY 100 EAST: All of Highway #100 East right of way described as follows: Beginning at the intersection of State

Highway #100 East (formerly Highway 51) and U.S. Highway #59
in Section 2, Township 15 North, Range 25 East; thence in an
Easterly direction to the intersection of the West line of
Section 12, Township 15 North, Range 25 East

a plat of which said property is attached hereto and made a part hereof as though
described herein.

SECTION 2. That the real property herein described shall be designated as
the **HIGHWAY RIGHT-OF-WAY ADDITION** to the City of Stilwell, Oklahoma, and the
boundaries of said City are hereby changed to correspond to the legal description
first above given.

SECTION 3. That all ordinances, parts of ordinances in conflict herewith
are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists therefor, for the
preservation of the public peace, health and safety, an emergency is hereby
declared to exist by reason whereof this Ordinance shall be in full force and
effect from and after its passage and approval.
