

ORDINANCE NO. 280

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY AND DESIGNATING SUCH TERRITORY AS 1996 ADDITION TO THE CITY OF ~~STILWELL~~, OKLAHOMA; AND DECLARING AN EMERGENCY.

BE IT ORDAINED, by the Mayor and Council of the City of Stilwell, Oklahoma:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to-wit:

TRACT 1:

A tract of land containing 0.60 acre more or less, being described as the North 8.00 feet of the South 160.00 feet of the West 300.00 feet of the NW NW SW of Section 3, Township 15 North, Range 25 East, Indian Base and Meridian

TRACT 2:

A tract of land containing 0.45 acre more or less, being described as the North 122.00 feet of the South 577.00 feet of the West 160.00 feet of the SW NW SW of Section 3, Township 15 North, Range 25 East, Indian Base and Meridian

TRACT 3:

A tract of land containing 0.33 acre more or less, being described as the North 90.00 feet of the South 455.00 feet of the West 160 feet of the SW NW SW of Section 3, Township 15 North, Range 25 East, Indian Base and Meridian

TRACT 4:

A tract of land containing 0.68 acre more or less, being described as the North 185.00 feet of the South 365.00 feet of the West 160.00 feet of the SW NW SW of Section 3, Township 15 North, Range 25 East, Indian Base and Meridian

TRACT 5:

A tract of land containing 4.01 acres more or less, being described as the South 180.00 feet of the NW SW of Section 3, Township 15 North, Range 25 East, Indian Base and Meridian

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as

the 1996 ADDITION to the City of Stilwell, Oklahoma, and the boundaries of said City are hereby changed to correspond to the legal description first above given.

SECTION 3. That all ordinances, parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists therefor, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
