

ORDINANCE NO. 283

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY AND DESIGNATING SUCH TERRITORY AS THE SHERIDAN PATTERSON ADDITION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED, by the Mayor and City Council of the City of Stilwell, Oklahoma:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to-wit:

A subdivision of that portion of the NW1/4 NW1/4 NE1/4 of Section 2, Township 15 North, Range 25 East, Adair County, Oklahoma, described as follows: Beginning at the Northeast corner of said NW1/4 NW1/4 NE1/4; thence South 00 degrees 08'00" West, along the East line of said NW1/4 NW1/4 NE1/4, a distance of 300.00 feet; thence South 10 degrees 01'08" West a distance of 102.06 feet; thence North 89 degrees 21'21" West a distance of 342.49 feet to the West line of the East 360.00 feet of said NW1/4 NW1/4 NE1/4; thence North 00 degrees 09'00" East, along said West line, a distance of 256.56 feet; thence South 89 degrees 59'00" West, along the South line of the North 140 feet of said NW1/4 NW1/4 NE1/4, a distance of 150.00 feet; thence North 00 degrees 08'00" East, along the West line of the East 150.00 feet of the West 300.00 feet of said NW1/4 NW1/4 NE1/4 a distance of 140.00 feet; thence North 89 degrees 59'00" East, along the North line of said NW1/4 NW1/4 NE1/4, a distance of 510.00 feet to the point of beginning

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the **SHERIDAN PATTERSON ADDITION** to the City of Stilwell, Oklahoma, and the boundaries of said City are hereby changed to correspond to the legal description first above given.

SECTION 3. That all ordinances, parts of ordinances in conflict herewith are hereby repealed.
