

CITY OF STILWELL ORDINANCE NO. 339

AN ORDINANCE AMENDING THE PROVISIONS OF ORDINANCE NO. 108 OF THE CITY OF STILWELL, AMENDED BY ORDINANCE 214, AND PROHIBITING THE DELIVERY, SALE POSSESSION OR MANUFACTURE OF DRUG PARAPHERNALIA AND PROVIDING FOR SEVERABILITY.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, STATE OF OKLAHOMA:

SECTION 1. That from and after the effective date of this ordinance, Section 1 of Article I of Ordinance No. 108, be and the same is hereby amended to read as follows, to wit:

SECTION 1. GENERAL OFFENSE, PENALTY.

Except in cases where a different punishment is now or may hereafter be prescribed by ordinance, any person who commits an offense shall, upon conviction, be fined up to the maximum amount allowed under the municipal ordinances for the City of Stilwell plus court costs.

SECTION 2. That from and after the effective date of this ordinance, Section 11 of Article II of Ordinance No. 108, be and the same is hereby amended to read as follows, to wit:

SECTION 11. OBSCENE OR INDECENT WRITING, ETC.

Every person who willfully either writes, composes, stereotypes, prints, publishes, sells distributes or keeps for sale or exhibits any obscene or indecent writing paper, magazine or book, or indecent picture or print of any description, or molds, cuts or otherwise makes any obscene or indecent figure or form is guilty of a misdemeanor.

SECTION 3. That from and after the effective date of this ordinance, Article VII of Ordinance No. 108, be and the same is hereby amended to read as follows, to wit:

SECTION 42. PENALTY.

Any violation of any provision contained in this ordinance is an offense against the City and upon conviction of any such offense the violator shall be punished by a fine up to the maximum amount allowed under the municipal ordinances for the City of Stilwell, Oklahoma, plus court costs.

SECTION 4. That from and after the effective date of this ordinance, Section 43 of Article VIII of Ordinance No. 108, be and the same is hereby amended to read as follows, to wit:

SECTION 43. PROHIBITION AGAINST THE DELIVERY, SALE POSSESSION OR MANUFACTURE OF DRUG PARAPHERNALIA.

No person shall deliver, sell, possess or manufacture drug paraphernalia knowing, or under circumstances where one reasonably should know, that it will be used to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack,


store, contain, conceal, inject, ingest, inhale or otherwise introduce into the human body a controlled dangerous substance in violation of the Uniform Controlled Dangerous Substances Act of the Statutes of the State of Oklahoma.

SECTION 5. That all other parts of said Ordinance shall remain the same and remain in full force and effect.


SECTION 6. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.
