ORDINANCE NO. 72

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF STILWELL, OKLAHOMA AND CHANGING THE CITY BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS THE SQUIRES COUNTRY ESTATES ADDITION TO THE CITY OF STILWELL, OKLAHOMA

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. The following described real property situate, adjacent to and abutting upon the present limits of the City of Stilwell, Oklahoma shall be annexed to and be a part of the City of Stilwell, Oklahoma, to wit:

A tract of land in the W $\frac{1}{2}$ of NW $\frac{1}{4}$ of Section 11, Township 15 North, Range 25 East, Adair County, Oklahoma, more particularly described as follows: Beginning at the NW corner of the NW $\frac{1}{4}$ of Section 11, Township 15 North, Range 25 East, Thence 967.35 feet, N 89°34'00"E, thence 660.00 feet South;

thence 330.38 feet N 89°34'07" E, thence 890 feet South 00°02'00" East, thence 638.19 feet South 89°34'17" West; thence 890 feet North 00°01'00" West; thence 658.99 feet South 89°34'07" West; thence 208.33 feet North 00°01'00" West; thence 329.60 feet North 89°34'00" East; thence 416.66 feet North 00°01'00" West; thence 329.60 feet South 89°34'00" West; thence 35 feet North 00°01'00" West to the point of beginning; and a tract of land 5 foot either side of a center line described as follows, to wit: Beginning at the Northwest corner of Section 11, Township 15 North, Range 25 East; thence North 224.5 feet to point where the East side of South 3rd Street in the City of Stilwell, Oklahoma intersects the North edge of the Kansas City Southern Railroad Right of Way to the present limits of the said City of Stilwell, Oklahoma, a plat of which is hereto attached and made a part hereof as though fully described herein.

SECTION 2. That the property herein described shall be designated as the Squires Country Estates Addition to the City of Stilwell, Oklahoma, a dedication, certification and plat of which is attached hereto and made a part hereof as though fully described herein.

SECTION 3. This Ordinance shall be in force and take effect from and after its passage, approval and publication required by law.
