

ORDINANCE NO. 86

AN ORDINANCE PROVIDING FOR THE CREATION OF THE OFFICE OF NATURAL GAS INSTALLATION INSPECTOR, PROVIDING FOR THE INSPECTION OF ALL NATURAL GAS INSTALLATIONS WITHIN THE CITY OF STILWELL, OKLAHOMA, AND PROVIDING A FEE THEREFOR; PROVIDING FOR THE REQUIREMENT OF ANY PERSON INSTALLING NATURAL GAS FACILITIES TO HOMES OR BUSINESSES WITHIN THE CITY OF STILWELL, OKLAHOMA, TO HAVE IN FORCE AND EFFECT LIABILITY INSURANCE; PROVIDING FOR PENALTY FOR FAILURE TO COMPLY WITH THE PROVISIONS OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That there is hereafter created the office of Natural Gas Inspector in and for the City of Stilwell, Oklahoma, said person to be named by the Mayor and Council of said City.

SECTION 2. That from and after the date of passage of this Ordinance, all installations to homes and businesses and any other buildings of any type or nature from the natural gas meter into the said homes, buildings or other dwellings shall be inspected prior to the turning on or usage of any natural gas within the City of Stilwell, Oklahoma, said inspection to be made by the person designated by the Mayor and Council as aforesaid; and, in the event that the said Natural Gas Installation Inspector should, in his judgement, feel that the use of natural gas through existing facility or those installed in an improper manner would be inherently dangerous to the occupant or occupants of such house, business or dwelling, then he shall notify the occupant or owner thereof of such condition and the natural gas shall not be turned on at such place.

SECTION 3. That there shall be charged a fee for each installation inspected by said Natural Gas Installation Inspector of \$2.50, which said fee shall be paid by the owner of each installation inspected.

SECTION 4. That all persons who shall install natural gas facilities for hire within this City of Stilwell, Oklahoma, from and after the date of the passage of this Ordinance, shall be first required to procure liability insurance, made in favor of those persons to whom natural gas installation shall be bade by said persons, in the amount of \$25,000.00 for personal injuries sustained, \$50,000.00 for each occurrence and \$25,000.00 property damage, which said insurance policy shall be presented to the City Clerk of Stilwell, Oklahoma, and filed as a part of his records.

SECTION 5. That any person violating any of the provisions of this Ordinance shall be subjected to a fine of \$50.00 and costs for each separate occurrence.

SECTION 6. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 7. WHEREAS, an immediate necessity exists; therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in force and effect from and after its passage and approval.
