

ORDINANCE NO. 77

AN ORDINANCE CREATING AN AMBULANCE SERVICE FOR THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That there is hereby created a department of the City which shall be designated the "Stilwell Ambulance Service."

SECTION 2. That said ambulance service shall be operated by the Council of said City, and the said Council shall employ such persons as are necessary to operate such ambulance service and shall collectively acting determine the amounts of salaries to be paid such persons, and shall collectively determine the amount of equipment to be utilized in the operation of said ambulance service and the amounts to be paid for such equipment; and further, that the said Council shall employ some suitable person to be the manager of the said ambulance service at a salary that shall be determined by collective action by the said Council.

SECTION 3. That the said City Council shall be ordinance prescribe the rates to be charged to persons who shall request or require the services of said ambulance service; that all collections or expenditures made incident to the operation of said ambulance service shall be done in the name of the "City of Stilwell, Oklahoma."

SECTION 4. That the funding for the said ambulance service shall be derived from the Sales Tax Ordinance which became effective on July 1, 1971, and which shall be equal to one-half ( $\frac{1}{2}$ ) of the total sales tax collected by the City of Stilwell on or after July 1, 1971; that the said monies shall be forthwith placed in a fund which shall be designated the "Ambulance Fund of the City of Stilwell, Oklahoma;" that all monies spent or collected by the said City Council in any connection with the said ambulance service shall be spent from or put into said Ambulance Fund and said fund shall not be invaded for any other purpose than the operation of said ambulance service until such time as the said City Council shall be ordinance provide for the expenditure of such fund in some other manner.

SECTION 5. That the manager of said ambulance service shall attend such regular meeting of the said City Council and shall present to said Council a monthly financial statement of said ambulance service which shall contain the following items: Cash on Hand, Accounts Receivable, Accounts Payable, Equipment, Accrued Depreciation, Income and Expenses; and that no salary shall be paid to said manager until the presentation of such report as hereinbefore specified.

SECTION 6. That the employees (including manager) of said ambulance service shall log each call or trip that they shall make during the operation of said ambulance service and shall show thereon the charge prescribed by the City Council, and said manager shall present such log with the aforementioned financial statement at each regular meeting of the said City Council.

WHEREAS, an immediate necessity exists for the institution of an ambulance service for which an immediate need exists; therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
