

ORDINANCE NO. 243

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY AND DESIGNATING SUCH TERRITORY AS THE SUBWAY ADDITION TO THE CITY OF STILWELL, OKLAHOMA, AND PROVIDING FOR AN EMERGENCY.

BE IT ORDAINED, by the Mayor and Council or the City of Stilwell, Oklahoma:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to-wit;

A tract of land in the S/2 SW SW of Section 26, Township 16 North, Range 25 East, Adair County, Oklahoma, described as follows; Commencing at the NW corner of said S/2 SW SW; thence S.00 degrees 09'00" W., a distance of 150.00 feet; thence S.89 degrees 59'00" E., a distance of 613.65 feet; thence S.00 degrees 09'00" W., a distance of 110.00 feet; thence S.89 degrees 59'00" E., a distance of 86.99 feet to the point of beginning; thence S.89 degrees 59'00" E., a distance of 200.00 feet to the Westerly right-of-way line of Highway No. 59; thence S.18 degrees 27'00" E., along said Westerly right-of-way line, a distance of 84.34 feet; thence N.89 degrees 59'00" W., a distance of 226.72 feet; thence N.00 degrees 01'00" E., a distance of 80.00 feet to the point of beginning, containing 17.068 square feet or 0.3918 acres, more or less

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the **SUBWAY ADDITION** to the City of Stilwell, Oklahoma, and the boundaries of said City are hereby changed to correspond to the legal description first above given.

SECTION 3. That all ordinances, parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists therefor, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
