

ORDINANCE NO. 60
 AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS THE LEISURE LANE SUB-DIVISION TO THE CITY OF STILWELL, OKLAHOMA. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION I.

That the following described real property situate, adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to wit:

TRACT ONE — The South 511 feet of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of SE $\frac{1}{4}$ in Section 34, Township 16 North, Range 25 East, less the following described tracts, to wit: the East 140 feet of the South 100 feet of NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of SE $\frac{1}{4}$ and South 125 feet of the East 188 feet of the North 275 feet of NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of SE $\frac{1}{4}$ in said Section.

TRACT TWO — The East 112 yards of the North 130 yards of the SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of SE $\frac{1}{4}$ in Section 34, Township 16 North, Range 25 East, less a tract of land described as follows: Beginning at the NE corner of SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of SE $\frac{1}{4}$ in Section 34, thence West a distance of 140 feet, thence South a distance of 66 feet, thence in an Easterly direction to a point 89 feet South of the point of beginning, thence North 89 feet to the point of beginning, a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION II.

That the real property herein described shall be designated as the Leisure Lane Sub-Division to the City of Stilwell, Oklahoma.
