AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF STILWELL, OKLAHOMA AND CHANGING THE CITY BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS THE CITY PARK ADDITION TO THE CITY OF STILWELL, OKLAHOMA: BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SAM O. LOVE, of lawful age, being duly sworn and authorized says that he is Publisher of the Stilwell Democrat-Journal Inc., a weekly newspaper published in the Town of Stilwell, Adair County, Oklahoma, a newspaper qualified to publish legal notices, advertisements and publications as provided in Section 106 of Title 25, Oklahoma Statutes 1971, as amended, and complies with all other requirements of the laws of Oklahoma with reference to legal publications.

SECTION 1. That the following described real property situate adjacent to and abutting upon the present limits of the City of Stilwell, Oklahoma shall be annexed to and become a part of the City of Stilwell, Oklahoma, to wit:

The 1/2 of SE 1/4 of NW 1/4 and the W 1/2 of NE 1/2 of SW 1/4 and the NE 1/4 of NW 1/4 of SW 1/4 and a ten (10) foot strip of land situate in the Southwest quarter described as follows, to wit: Beginning at a point where the East line of the KCS Railroad right-of-way intersects the South line of the NE 1/4 of NW 1/4 of SW 1/4 and thence running Southeasterly along the said KCS Railroad right-of-way to a point where said Railroad right-of-way intersects the North side of State Highway No. 100 right-of-way, thence due West along the South line of said Southwest quarter to a point where said line intersects the Redbud Addition to the City of Stilwell, Oklahoma, all being in Section 26, Township 16 North, Range 25 East

A plat of which is attached hereto and made a part hereof as though fully described herein.

SECTION 2. That the property herein described shall be designated as the City Park Addition to the City of Stilwell, Oklahoma, a dedication, certification and plat of which attached hereto and made a part hereof as though fully described herein.

SECTION 3. This ordinance shall be in force and take effect from and after its passage, approval and publication required by law.
