ORDINANCE NO. 76

AN ORDINANCE AMENDING SECTION 5, TAX RATE -- SALES SUBJECT TO TAX, OF ORDINANCE NO. 59 KNOWN AS THE "STILWELL SALES TAX ORDINANCE" BY INCREASING THE TAX IN SAID SECTION 5 FROM ONE PERCENT (1%) TO TWO PERCENT (2%); AND DECLARING AN EMERGENCY.

EMERGENCY ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STILWELL, ADAIR COUNTY, STATE OF OKLAHOMA:

SECTION 1. CITATION AND CODIFICATION.

This Ordinance shall be known and may be cited as "Amendment to Stilwell Sales Tax Ordinance Rate, " and shall be codified by changing the language of Section 5 of Ordinance No. 59 of the General Ordinances of Stilwell.

SECTION 2. (RATE)

Ordinance No. 59 is hereby amended to change the tax rate in Section 5 of said Ordinance from the present Excise Tax of one percent (1%) to two percent (2%) upon the gross proceeds or gross receipts derived from all sales taxable under the Sales Tax Law of Oklahoma.

SECTION 3. EFFECTIVE DATE.

This Ordinance shall become and be effective on and after July 1, 1971, subject to approval of a majority of the registered voters of Stilwell voting on same in the manner prescribed by 11 O.S., 1961, Section 61.

SECTION 4. PROVISIONS CUMULATIVE.

The provisions hereof shall be cumulative and in addition to any and all other taxing provisions of City ordinances.

SECTION 5. SEVERABILITY.

The provisions of this Ordinance are severable and, if any part or provision hereof shall be adjudged invalid by any court of competent jurisdiction, such adjudication shall not affect or impair any of the remaining parts or provisions hereof.

SECTION 6. EMERGENCY.

WHEREAS, it being immediately necessary for the preservation of the peace, health and safety of Stilwell and the inhabitants thereof that the provisions of this Ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof this Ordinance shall take effect and be in full force from and after its passage, as provided by law.
